### PHARMACOLOGICAL ACTION

The exact mechanism of  
action of saline nasal  
irrigation is not known.  
It works by rinsing and  
moisturising the nostrils.

### INDICATIONS:

Indicated as an aid to assist  
in relieving symptoms of  
Sinusitis and Postnasal Drip,  
dry or irritated  
nasal passages.

### CONTRA-INDICATIONS:

Known hypersensitivity to  
any of the ingredients.  
No specific interactions are  
known at this time.

should only use this product

### DOSAGE & DIRECTIONS FOR USE:

2-4 Sprays in each nostril.  
Children half the dosage.  
Remove cap, carefully place  
nozzle tip loosely into the  
nostril, depress the spray  
mechanism, and sniff.  
Repeat the process for the  
other side/nostril. Blow your  
nose and repeat if necessary.

### INTERACTIONS:

None known.

### SIDE EFFECTS

If the inside of the nose is  
dry and irritated, stinging  
may occur when nasal spray  
is used.

### KNOWN SYMPTOMS OF OVERDOSAGE AND PARTICULARS OF TREATMENT:

No known symptoms of

overdosage. In the event  
of suspected overdosage,
